### Return Policy

GLOBAL TREND TECHNOLOGY TRADING INC accepts returns for refunds or exchanges, subject to the following:

## 7 DAYS

You can return purchased items to GLOBAL TREND TECHNOLOGY TRADING INC within 7 days of the date they were shipped to you. After 7 days, we do not accept returns. See our Warranty Policy for warranty Use and procedures.

## RETURN TO MANUFACTURER

### AUTHORIZATION

Before returning an item, send GLOBAL TREND TECHNOLOGY TRADING INC an e-mail: [globaltrenttradingtech@gmail.com](mailto:globaltrenttradingtech@gmail.com) to explain the reason for the return, the details of your original order, and whether you want a refund or an exchange. As appropriate, we will issue you an RMA number, which you need to include in the package for the returned item, along with a copy of the original order information. We do not accept returned items for which an RMA has not been issued.

### CONDITION

The item must be unused, undamaged, complete with all parts and accessories, in the same condition you received it, and in its original packaging. Consumables, such as powder, binder, curing agent, and ink, will not be accepted if packaging is opened.

## SHIPPING

Pack the item according to our instructions to prevent damage in transit. In case of a return for repair covered by our one-year warranty, GLOBAL TREND TECHNOLOGY TRADING INC will cover the cost of shipping. For other returns, insure the package for its value, as you will be responsible for damage in transit. Use a shipping carrier that allows you to track the package. ## REFUND
